The Board of Trustees met in regular session on December 13, 2022. President Smith called the meeting to order at 6:00 p.m. Roll call found the following Trustees present: Jeff Wirth, Quincy Pool, Tara Kapple, Woody Besse, and Joe Froeliger. Trustee Cox arrived at 6:07.

- ** Trustee Pool made a motion to approve the Treasurer's report for November.

 Seconded by Trustee Besse. Roll call was as follows: aye Pool, Besse, Froeliger, Wirth, and Kapple, nay none.
- ** Trustee Kapple made a motion to approve paying the bills. Seconded by Trustee Froeliger. Roll call was as follows: aye Kapple, Froeliger, Besse, Pool, and Wirth, nay none.
- ** Sales Tax for August was \$10,100.23. November recycling was 21,690 pounds.
- ** The Board received a thank-you from Teresa.

Police Report

The new Tahoe patrol car is in Des Moines and getting its lights and other equipment installed.

The new officers, Jordan Garrison and Michael Barger, have graduated from the police academy and will start patrolling on their own in February.

Chief Hawk is asking to cash in 60 hours of unused vacation time. Trustee Wirth made a motion to compensate Chief Hawk for his 60 hours of unused vacation time. Seconded by Trustee Kapple. Roll call was as follows: aye – Wirth, Kapple, Pool, Cox, Besse, and Froeliger, nay – none.

Trustee Cox made a motion to accept Tom Border's resignation as Cemetery Sexton Pro-Tem and accept President Smith's appointment of Tod McCullough to the position. Seconded by Trustee Pool. Roll call was as follows: aye – Cox, Pool, Kapple, Wirth, Froeliger, and Besse, nay – none.

Trustee Cox made a motion to give Village employees a Christmas bonus following past procedure with the addition of employees of less than 1 year receiving a \$50.00 gift card. Seconded by Trustee Kapple. Roll call was as follows: aye – Cox, Kapple, Pool, Besse, Froeliger, and Wirth, nay – none.

Public Works

After a presentation by Shannon, Trustee Besse made a motion to approve the use of American Rescue Plan Act Funds for lift station upgrades. Seconded by Trustee Kapple. Roll call was as follows: aye – Besse, Kapple, Pool, Cox, Wirth, and Froeliger, nay – none.

Also, the locator for sewer and water lines is not working accurately. A representative of a company is coming and will give a recommendation for a new locator that has GPS and is appropriate for what the Village needs to complete its projects. Trustee Pool made a motion to give the sewer and water committee, Woody and Jeff, plus Marcia and Joel permission to authorize the purchase of a new locator, after learning the professional's recommendation, not to exceed \$9721.00.
